The fee provides for all aspects of assistance noted below and is usually more than covered in the savings on price, increased trade-in value, or auto loan-credit assistance along with the savings of time/hassle negotiating a traditional car deal.

While **My Carlady** staff is assisting in aspects of the auto purchase process, all personal information is kept strictly confidential; however, some lenders may require personal contact before approving an auto loan. By signing this agreement and making payment of the fee, the buyer understands there are no stated or implied guarantees regarding auto loan approval. The buyer is responsible for insurance of the vehicle prior to delivery, in accordance with state law.

The **My Carlady** service agrees to suggest up to ten (10) vehicles that fit the requested criteria of the buyer. Appointments for test drives and delivery are determined on an individual need basis. Delivery of the vehicle is made in accordance with the state law and buyer's schedule. All warranties must be in writing, and are in accordance with governing state law and manufacturer new car warranty.

The buyer agrees to provide all pertinent information regarding vehicle selection, credit situation, time constraints and delivery requirements prior to entering into the service arrangement.

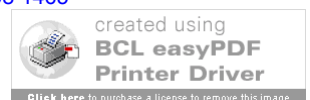
